Subject: SS7 BellSouth Interconnection Customers - Notification of Account Owner

Availability

This is to advise that the BellSouth Line Information Database (LIDB) can provide Account Owner information in Calling Card (CC) and Billed Number Screening (BNS) responses. Account Owner is a LIDB parameter that uniquely identifies Local Service Providers (LSP).

The Account Owner parameter uses standard National Exchange Carrier Association (NECA) Company Codes to identify the LSP for billing. BellSouth will return this information to the interconnection customer's network, once the customer confirms its ability to receive Account Owner information.

Before requesting Account Owner information in your company's CC and BNS responses, please verify that your query-originating platform can accommodate the new parameter in the Transaction Capability Application Part (TCAP) portion of the response message. If you request Account Owner information, but your query-originating switch is non-compliant, protocol errors on responses from BellSouth's LIDB will occur. Protocol errors may result in your switch, denying alternate billing requests that may otherwise have been allowed on your platform.

The attached form will provide BellSouth with the information needed to begin returning Account Owner information to the interconnection customer's platform. Please complete the attached form and return via e-mail or fax as indicated at the bottom of the form. Upon receipt of your request, BellSouth will process it according to the effective date selected. A copy of the completed form will be returned to your company as confirmation that the change has taken place. There is no additional charge for obtaining Account Owner information in CC and BNS responses.
