Subject: CLECs – Update of the Local Exchange Ordering - Implementation Guide

(LEO-IG) Volume 1, Issue 7X

This is to advise that the LEO-IG, Volume 1, Issue 7X, is scheduled to be posted to the BellSouth Interconnection Services' Web site by Friday, November 30, 2001. This LEO-IG update will affect documentation as well as electronic order processing that may impact CLEC operations.

Changes scheduled for Issue 7X are as follows: (See attachment for detailed updates.)

- Update the Resale and Port Service sections for the Feature–Feature Codes field to add a note stating: "This field should be populated with the Line Class of Service Uniform Service Order Codes (USOC), when the FEATURE DETAIL field is populated with 'ZSRC' when ordering Selective Call Routing via Selective Routing codes."
- Show Local Serving Office (LSO) as not a required field (change 'R' to "N") on Usage table for REQTYPE B.
- Change Example from "UNE" to "BST 736119" for the PROJECT field.
