This is to advise that effective with the deployment of Release 10.2, the Business Rules for TN & Address Validation, as per attachment, will apply for electronic and manually processed LSRs.

This information will appear in the BellSouth Business Rules – Local Ordering (BBR-LO), Issue 9S, scheduled to be posted to the BellSouth Interconnection Services' Web site by Wednesday, December 5, 2001. These changes are related to CCP-CR0133 and CCP-CR0371. This BBR-LO update will affect documentation and electronic order processing that may impact CLEC operations.

Data Element Directory

SANO - Service Address House Number

Identifies the house number of the service address.

VALID ENTRIES: None

DATA CHARACTERISTICS: Up to 8 alpha/numeric characters

EXAMPLE: 450

CONDITIONAL USAGE NOTES:

Note 1: Prohibited when the SASN field is *not* populated at this location.

Note 2: Required when SADLO is *not* populated

Note 3: Required unless the service is on a rural unnumbered street.

Note 4: (REQTYP A, E, M, N) Required when ACT = C and LNA = N.

BUSINESS RULES:

Rule 1: Address must be RSAG valid.

Rule 2: When SANO is provided for Telephone Number/House Number Validation, Street Name (SASN), EU-CITY, EU-STATE, and EU-ZIPCODE address fields must be populated.

Data Element Directory

SASN - Service Address Street Name

Identifies the street name of the service address.

VALID ENTRIES: None

DATA CHARACTERISTICS: Up to 50 alpha/numeric characters

EXAMPLE: CAMINO RAMON

CONDITIONAL USAGE NOTES:

Note: (REQTYP A, E, M, N) Required when ACT = V, P, C or Q and either LNA = N or EUMI = Y, otherwise optional.

BUSINESS RULES:

Rule 1: If no street name exists, may be rural route, general delivery or other description for delivery/service destination.

Rule 2: Address must be RSAG valid.

Rule 3: Rural unnumbered areas must be preceded by an "@" symbol in order to be RSAG valid.

Rule 4: SASN without SANO must have an "@" symbol in the first position at this location.
