Subject: CLECs – Update of the BellSouth Business Rules for Local Ordering (BBR-LO), Issue 9S

This is to advise that BBR-LO, Issue 9S, is scheduled to be posted to the BellSouth Interconnection Services' Web site on Wednesday, December 5, 2001. This BBR-LO update will affect documentation as well as manual and electronic order processing that may impact CLEC operations and will be effective upon implementation of Release 10.3 scheduled for January 5, 2002.

The BBR-LO is now separated into two books. The first book will include General Local Ordering Information and the R/C/O Tables. The second book will include Data Element Dictionary and Appendices (Appendix A & B). The Purpose and Introduction Sections will be duplicated. The Revision/History section will now only encompass the changes associated with the book being revised.
