Subject: All Interconnection Services Customers – BellSouth Obsolete or Discontinued Services

In order to better serve customer needs and streamline its service offerings, BellSouth will discontinue or make obsolete less commonly used services and replace with more up-to-date services in the states as detailed in the table below. BellSouth tariff filings to change obsolete restrictions for certain residential calling services began in July 2001 and will continue into 2002. The table below indicates the actions to be applied to services in the following state:

Alternate services will be offered to BellSouth customers as a replacement for these services. For customers who currently subscribe to expanded calling plans, BellSouth also offers Optional Calling Plans that can help reduce local toll calling costs. The deadline for selecting alternate services is as following:

Louisiana	February 1, 2002
Florida	February 1, 2002
Kentucky	March 31, 2002

After that date, automatic conversion to alternate services most closely matching existing services will begin as shown in the table below. An incentive of one free month of access line service is available to customers in Louisiana until December 31, 2001, and customers in Kentucky until January 31, 2002,

Alternate Service Descriptions:

<u>Flat Rate service</u> - call anyone, anywhere within your local calling area and talk as long as you like, as often as you like, all for one monthly rate.

BellSouth® Area Plus® service - offers local service <u>plus</u> an expanded local calling area that includes many surrounding communities. (Local toll calls are calls made to telephone numbers in nearby communities that are outside your local calling area.)

<u>The BellSouth® Complete Choice® plan</u> - includes basic local service plus features such as Call Waiting, Call Forwarding, Caller ID and Three-Way Calling.

<u>BellSouth® Area Plus® service with the BellSouth® Complete Choice® plan</u> - combines daily calling convenience with local toll calling flexibility. Includes basic local service plus unlimited local toll calling.

Local Optional Service - expands the local calling area to 40 miles. Some local calls may require 10-digit dialing (area code + the number). Available in Louisiana only.

Local Optional Service Option B Economy - expands the local calling area to 40 miles. Some local calls may require 10-digit dialing (area code + the number). Available in Louisiana only.

Local Optional Service Option B - expands the local calling area to 40 miles. Some local calls may require 10-digit dialing (area code + the number). Available in Louisiana only.

<u>Area Calling Service without LUD</u> – expands the local calling area to designated communities beyond the basic local calling area. This plan has a monthly rate for the line; usage charges apply for local calls. Available in Kentucky only.

<u>Area Calling Service Premium</u> – expands the local calling area to designated communities beyond the basic local calling area. This plan has a flat monthly rate. Available in Kentucky only.
