Subject: CLECs –Updates to the BellSouth Products and Services Interval Guide – Issue 5A

This is to advise that BellSouth is making several additions and updates to its Products and Services Interval Guide. The following additions/updates, designed to enhance the CLEC ordering process, will appear in Issue 5A of the Interval Guide scheduled to be posted to the BellSouth Interconnection Services' Web site by Friday, January 31, 2002:

- Complex Resale Interval Table (REQTYPs E, N, P) (ACT N, T, C, P, Q, V) to remove asterisk (*) following ISDN/BRI because service inquiry is not needed.
- Complex Switched Combination Interval Table (REQTYP M) (ACT N, V, C) to remove asterisk (*) following ACT N (Georgia only), C, because service inquiry is not needed.
- Update standard interval to same business day for Local Exchange Line-Residence and Local Exchange Line-Business under ACT of Y for Non-Complex (Residence, Business, Coin) Resale.
- All complex services for Local Number Portability (LNP) will be project-managed with the exception of Simple Resale/Retail Services.
- In Non-Complex (Residence, Business, Coin) Switched Combinations section, updated table under ACT of C, P, V, W (Lines and Line Features) to remove references to 3:00 PM Eastern Time.
- Introduction Change non-mechanized Firm Order Confirmation (FOC) interval to 24 business hours.
- Non-Complex (Residence, Business Coin) Resale Modify Targeted Local Service Request (LSR) Processing Interval as follows: Manual LSRs – 24 business hours.
- Non-Complex (Residence, Business Coin) Switched Combinations Modify Targeted LSR Processing Interval as follows: Manual LSRs 24 business hours.
- Unbundled Network Elements (UNE) Modify Targeted LSR Processing Interval as follows: Manual LSRs 24 business hours.

- Number Portability Modify Targeted LSR Processing Interval as follows: Manual LSRs – 24 business hours.
- Operator Services and Directory Assistance Modify Targeted LSR Processing Interval as follows: Manual LSRs 24 business hours.
- Complex Resale Interval Table (REQTYPs E, N, P) Add assumption -LNP to Resale/UNE Switched Combo (UNE-P) migrations interval process is a minimum of 10 business days.
- ACT of C, P, Q, V Line Feature Changes and Non-Dispatch Switch with Changes
 Add assumption LNP to Resale/UNE Switched Combo (UNE-P) migrations interval process is a minimum of 10 business days.
- ACT of C, P, Q, V (New Line Additions) and ACT of N, T Add assumption -LNP to Resale/UNE Switched Combo (UNE-P) migrations interval process is a minimum of 10 business days.
- Non-Complex (Residence, Business, Coin) Switched Combinations -Add assumption - LNP to Resale/UNE Switched Combo (UNE-P) migrations interval process is a minimum of 10 business days.
- Local Number Portability Add assumption -LNP to Resale/UNE Switched Combo (UNE P) migrations interval process is a minimum of 10 business days.
