Update to the LNA Activity Table

This is to advise that when BBR-LO, Issue 10.5, was updated to add LNA of G for ACTs of P and Q, the LNA of "W" entry was inadvertently removed. This letter is to advise that the LNA of W entry will be restored in the ACT/LNA table located under the CONDITIONAL USAGE NOTES for the LNA field in the Port Service section. This is associated with Change Request CR0680.

This update will appear in the BBR-LO (Issue 10.4rev) scheduled to be posted to the BellSouth Interconnection Services' Web site on April 5, 2002.

The attachment to this letter can be used as an update when reviewing the BBR-LO (Issue 10.5). This update will be included in the BBR-LO (Issue 10.5rev), which will be posted on the BellSouth Interconnection Services' Web site after Release 10.5 is implemented.

BUSINESS RULES:

Rule 1: ACTTYP T and LNA C is necessary to request Inside Move. NOTE: Criteria for an inside move is defined in each state specific tariff.

Rule 2: If inside move involves the rearrangement of wiring, all applicable USOCs must be provided on the LSR.

Manual:

Rule 3: When LNA = L or B, the ACT field must equal "S". This allows the end user to seasonally suspend or restore some of the lines on an account.
