Subject All Interconnection Services Customers – BellSouth Obsolete or Discontinued

Services

In order to better serve customer needs and streamline its service offerings, BellSouth will discontinue or make obsolete less commonly used services and replace with more up-to-date services in the states as detailed in the table below. BellSouth tariff filings to change obsolete restrictions for certain residential and business calling services began in July 2001, and will continue through December 2002.

The table below indicates the actions to be applied to services in the following state:

Alternate services will be offered to BellSouth customers as a replacement for these services. For customers who currently subscribe to expanded calling plans, BellSouth also offers Optional Calling Plans that can help reduce local toll calling costs. The deadline for selecting alternate services is August 15, 2002, for all three states.

After August 15, 2002, automatic conversion to alternate services most closely matching existing services will begin as shown in the table below.

Alternate Residence Service Descriptions:

Flat Rate service - calls anyone, anywhere within your local calling area and talk as long as you like, as often as you like, all for one monthly rate.

BellSouth® Area Plus® service - offers local service plus an expanded local calling area that includes many surrounding communities. (Local toll calls are calls made to telephone numbers in nearby communities that are outside your local calling area.)

The BellSouth® Complete Choice® plan - includes basic local service plus features such as Call Waiting, Call Forwarding, Caller ID and Three-Way Calling.

BellSouth® Area Plus® service with the BellSouth® Complete Choice® plan – combines daily calling convenience with local toll calling flexibility. Includes basic local service plus unlimited local toll calling.

Alternate Business Service Descriptions:

Business Flat Rate Service:

Call anyone, anywhere within your local calling area and talk as long as you like, as often as you like, all for one monthly rate.

Business Plus Option 1:

Business Plus Service is an optional statewide expanded local calling plan that provides LATA-wide local calling. Calls in the Basic Local Calling Area (BLCA) and Expanded Local Calling Area (ELCA) (out to LATA boundary) up to 7200 minutes-of-use, which equals 120 hours per line. All usage in the BLCA and ELCA is applied toward the minutes-of-use. Additional minutes-of-use will be billed at \$.05 per minute.

Business Plus Option 2:

Business Plus Service is an optional statewide expanded local calling plan that provides LATA-wide local calling. Unlimited calling (no usage charges) for calls in the BLCA and usage charges for calls in the ELCA (out to LATA boundary). A single rate per minute will apply on all calls to the ELCA.

Complete Choice® for Business:

Complete Choice[®] for Business Line Packages includes a line(s) and an unlimited amount of compatible services and features offered as listed on the service and feature list. If a customer subscribes to Complete Choice for Business Line Package, that customer is also eligible for Complete Choice for Business Messaging Packages and Complete Choice for Business Maintenance Packages.

Business customers may choose either a Business Plus Option 1 or Option 2 as their line within the Complete Choice Package.
