Subject: CLECs – Update to the BellSouth Business Rules for Local Ordering (BBR-LO),

Issue, 10.6current - Type of Service (TOS) Field for COIN Application

This is to advise that the BBR-LO, Issue 10.6current, is scheduled to be posted to the BellSouth Interconnection Service's Web site on Monday, August 26, 2002. The BBR-LO update includes the TOS field in the Data Element Dictionary for ordering COIN service.

This update primarily affects documentation changes for ordering COIN Unbundled Network Element-Platform (UNE-P) service via the Local Exchange Navigation System (LENS). Currently, there is a NOTE indicating that for LENS ordering of COIN UNE-P service, the TOS of 1BF will be used. The following change is effective immediately for ordering of UNE-P COIN service using the LENS application:

* = Use 1BF for COIN UNE-P conversions LENS users only.

** = Request for UNE-P COIN ACT of N; LENS users only, must be submitted manually.

Conditional Usage Notes: None

Business Rules:

Rule 1: TOS third character must *not* be F, if REQTYP = F.

Rule 2: If TOS first character is '2', the second character must be A, B, H, J, R or hyphen (-).

Rule 3: If TOS first character is '1', '2' or '3', the second character must not be a "C".

Rule 4: If TOS first character is '4', the second character must be "C".

Rule 5: TOS third character must be " - " (hyphen) if REQTYP = A, B, or C.

- Rule 6: TOS second character must be "D" when REQTYP = N.
- Rule 7: If REQTYP = P, the 2nd character of the TOS field must be "E".
- Rule 8: When the 2nd character of the TOS field is "E", the 1st character cannot be 2 or 4.
- Rule 9: TOS third character must be "F" (Flat Rate) when ordering SynchroNet® service.
- Rule 10: For REQTYP A, valid TOS entries are 1A-, 1B-, 1R-, 1P-, 2R-, 2P- and 19-.
- Rule 11: When both PBX and DID Trunks are on the same request, the second character of the TOS should be "J".
- Rule 12: For REQTYP B and C, the TOS field must reflect the service that is *currently* on the BellSouth CSR.
- Rule 13: If REQTYP = M (for UNE-P Centrex) the 2nd character of the TOS field must be "E" and the 3rd character must be "M".
- Rule 14: When REQTYP=E (WATS) the 2nd character of TOS is D and the 4th character must be W.
- Rule 15: When REQTYP=E (TFD) the 2nd character of TOS is D and the 4th character must be
- Rule 16: The Fourth Character in this field is only valid on Manually processed LSRs, prohibited with REQTYP B and C/NPT = D (LNP).
- Rule 17: If the data in the LNECLS SVC field is a business class of service, then the first character of the TOS must be 1.
- Rule 18: If the data in the LNECLS SVC field is a residence class of service, then the first character of the TOS must be 2.
- Rule 19: When REQTYP =E or M, the 4th character of "R" is required when ordering Remote Call Forwarding Service.
