Subject: All BellSouth Interconnection Services' Customers - Project Identification (ID) Standard for BellSouth Managed Projects

This is to advise that the following standards for the Project ID field on Access Service Requests (ASR) will become effective on December 17, 2002:

- 1. The first two characters of the Project ID must be BS, FL, AU, LT, AT or EU.
- Wireless Service Center: The beginning characters must be "BS" for all projects in all of the BellSouth region states, except Florida. In Florida, all project IDs must begin with "FL."
- Interexchange Carrier Service Center (ICSC): The beginning characters must be "AU", "BS" or "FL". "AU" must be used to identify projects where the Access Provider's end user customer has multiple locations. All other projects must begin with "BS", except for projects in Florida. In Florida, all project IDs must begin with "FL."
- Carrier Interconnection Switching Center (CISC): The beginning characters must be "LT" (Local trunking) or "AT" (Access trunking).
- **BBS End User Access Center (EUAC):** The beginning characters must be "EU" for projects in all states, except Florida. In Florida, all project IDs must being with "FL".
- 2. Characters in positions 3 through 16 of the Project ID will be used to identify the customer, location, type of project or project target due date. Requirements for characters in positions 3 through 16 will vary pursuant to the Service Center processing the ASR.
