3529/CR 1021	T, V, W, P, Q. Change the name of the Non-Switched combo document to Ordinarily Combined UNE-Combinations (OCU) including Enhanced Extended Links (EEL)
3550/CR 1082	Update R/C/O tables on LSR form for REQTYP=A, UDF ACT of N to move SCA and PBT fields from conditional to optional.
3564/CR 1091	Remove the Valid Entries on the LNECL SVC field from Resale form and add them to the Port Service form.
3566/CR 1092	Removing the PORTTYP field from the Port Service section of the Data Dictionary
3568/CR 1093	Changes to the data dictionary for the BLOCK field: Note 1 changes to: Prohibited with BA entry of N, Z, or Blank. Note 3 will be deleted.
3560/CR 1087	Change LSR for REQTYP C/ACT=V & P (LNP) to indicate LOCQTY field in the conditional column.
3561/CR 1089	Remove ERL field from RCO Table for UNE PBX for ACT of D
3573/CR 1099	Change Interval Guide to remove Project Managed for ACT=W f on REQTYP E, N, P and E & M (non-complex).
3584/CR 1105	Change TSP field in all applicable R/C/O tables to reflect (m) for manual ordering.
3586/CR 1106	Remove ACT of C in R/C/O tables for REQTYP C (LNP)

These changes will be reflected in the BBR-LO Guide with the implementation of ENCORE Release 12.0 scheduled for March 30, 2003.
