Subject: CLECs - Introduction of New Unbundled Network Elements-Platform (UNE-P) Uniform

Service Order Codes (USOC) in Georgia and North Carolina

As explained in Carrier Notification Letter SN9108368, BellSouth has been working to accommodate the ordering of the customized code restriction USOC CREX7 with UNE-P service in Georgia and North Carolina. The capability has been developed and this is to announce that such ordering is now available.

The implementation of this capability has resulted in the addition of four new UNE-P USOCs: UEPRV and UEPRU in Georgia; and UEPRZ and UEPRY in North Carolina. BellSouth's Retail to UNE-P USOC mapping in Georgia, North Carolina and Florida has also been modified as shown on the following table:

Your company's Interconnection Agreement must be amended before these new USOCs, highlighted above, may be ordered. During the week of July 14, 2003, BellSouth will be contacting CLECs with UNE-P lines and presenting each with a contract amendment adding these USOCs. Please execute and return this amendment expeditiously to avoid ordering clarifications.

On September 1, 2003, BellSouth will begin returning for clarification orders that are not ordered according to the table above and the ordering instructions provided in Version 11 of the UNE-P Web guide referenced below.

As information, the previous USOCs mapping is shown below:

In addition to implementing the aforementioned new UNE-P USOCS and USOC mapping, BellSouth is also adding the following additional BellSouth Retail USOCs to the USOC mapping matrix in the UNE-P Web guide:

LOGCL, LODCL, NN6CX, 1FP, 1JB, 1KB, 1KD, 1MJ, 1OK, 1ON, 1OO, 1OP, 1WB, 2EB, NAL2B, AMCCX, KN92K, KN92P, NLNCX, NN9CX, NN9CK, NN61X, AMC1X, TQB1X, KN91K, KN91P, NLN1X, NN91X, NN91K.

These BellSouth retail USOCs are mapped to existing UNE-P USOCs. Therefore, no change to the Interconnection Agreement is required.

Version 11 of the UNE-P Web guide, which will be available on July 15, 2003, will include all modified USOC mapping described in this Carrier Notification Letter. It will also provide detailed instructions for ordering the new UNE-P USOCs and ordering UNE-P service from the BellSouth Retail USOCs added to the mapping matrix. The ordering information provided in this guide for the additional USOCs shall serve as the specific instructions until the Local Ordering Handbook can be updated.
