CCP Number	Description Of The Change
1103	Modifications to CCNA and CUST fields for WLNP. Also delete a business rule in the LOH under WLNP Product, Restrictions and Limitations section. Stating "Wireless Type 1 provider may not request a port from another Wireless Type 1 or BST Wireline providers's account."

These changes will be reflected in the next update of the TCIF9 Release 14.0/LOH Version 14.0b, scheduled to be posted November 24, 2003.

# WLNP Modifications to the 14.0 and 15.0 LOH Submitted by Rodney Strawter

### **Product Restrictions and Limitations:**

- Directory Delivery is not applicable for WLNP
- If the WSP is ordering/requesting Foreign Listings associated with WLNP, they must submit a manual (faxed) LSR for processing (added 6-20-03)
- A wireless directory number may be ported to a wireline service provider as long as the resulting wireline serving address is geographically located within the wireline rate center (TMRC) associated with the wireless directory number (NPA NXX)
- Porting from a wireless carrier to BST is limited to ports within existing TMRC as
  defined in the LERG (Exception when porting from wireline to wireless Type
  2 the TMRC will not be validated).
- Wireless screening account TNs or Guide Numbers are not eligible to be ported.
- Wireless Service Request (WSR) forms are not valid when submitting a request to the LCSC. (WSR's should be submitted to the BellSouth Wireless Service Center)
- Existing LNP TN disconnect and TN reclaim industry procedures are applicable to WLNP and are found in the NPAC. (website <a href="https://www.npac.com">www.npac.com</a>
- Wireline to Wireless-An LSR request from a wireless service provider to port out a BST wireline number authorizes BST to disconnect a wireline number (BST, Reseller or UNE-P)
- Wireless to Wireline- a request from a wireless end user customer to port into BST as a wireline number authorizes BST to disconnect the port-in number from the donor wireless carriers account.
- Wireless to wireline Port in-A request from a wireless end user customer to port into BST as a wireline number authorizes BST to establish a wireline account for the port in number (BST, Reseller or UNE-P)
- Wireless Type 1 Provider may not request a port from another Wireless
  Type 1 or BST Wireline providers's account—[DELETE. This Rule 10-09-03]



# **CCNA**

Customer Carrier Name Abbreviation (LSR Page)

**Definition** Identifies the Common Language IAC code for the customer submitting the LSR and receiving confirmation.

**Def Notes NOTE1:** The format and structure of this field is defined by ANSI in document T1.251. Identification of

Telecommunications Service Provider Codes for the North American Telecommunications system.

NOTE 2: For a <del>occasional</del> customer who has not and probably will not obtain a CCNA, enter "CUS" in this field.

NOTE 3: CCNA is not necessarily the customer to be billed for the service. The billed party should be

specified in the ACNA field.

**Bus Rules** Rule 1: An entry of "CUS" requires an entry in the CC field.

Rule 2: [BULK] Required for UNE to UNE Bulk Migration.

Rule 3: When CCNA is populated with CUS, and the NNSP/CC is Wireless, then the CUST field must be populated with the Wireless Service Provider's

name.

Customer Name (LSR Page)

**Definition** Identifies the name of the customer that originated this request when that customer has not been assigned a CCNA.

**Def Notes None**

**VE Notes** None

Data Charact Up to 25 alpha/numeric characters

**CU Notes** Note 1: Required when CCNA is "CUS", otherwise optional.

**Bus Rules** 

Rule 1: When this field is populated, and the NNSP/CC field is Wireless, the data populated must be the wireless provider's name
