# Local Carrier Service Center (LCSC)

# **Description:**

The LCSC serves as the single point of contact (SPOC) for processing partially mechanized and manual local service request from the CLEC's for partial mechanized\* or manual ordering. The center serves resale-based CLECs, which subscribe to BellSouth services and offer them for resale to end-users within a given area, and facility-based CLECs, which provide service to end-users using their own network and facilities.

\* Questions concerning mechanized orders or ordering should be directed to the CSM or the EC Support Group.

The LCSC processes service order requests and provides status (clarification, order confirmation, service troubles, missed appointments) on service requests. The center also delivers authorized customer record information and performs billing inquiries and payment arrangements.

### **LCSC Call Handling Process**

The Service Representative will handle up to 5 PON issues for the customer per call.

Although the LCSC will provide assistance to customers for up to 5 PONs per call, BellSouth recommends that customers promptly contact the LCSC with individual PON issues. Customers should utilize the documents, reports and interface options provided by BellSouth prior to calling the LCSC. Customers that choose to collect PON issues and periodically call the LCSC for assistance impact the amount of resources available to assist other customers. Inappropriate customer procedures can hinder BellSouth's ability to provide dependable and consistent service to all customers.

In the event a Customer needs assistance with numerous PONs due to a BellSouth systemic problem, or a recurring problem with the same type error that appears to be due to a BellSouth issue, the customer may request that the LCSC review the problem to determine if a higher level of support is needed. A call back request will be submitted and a manager will respond within one hour.
