BellSouth® PreferredPack® plan for Manual Ordering Only (Latest revision posted on

December 1, 2004)

On January 9, 2004, BellSouth implemented a new BellSouth PreferredPack plan, which is available to Resale CLECs on a manual-ordering basis.

The following Uniform Service Order Code (USOC) and Field Identifier (FID) for this new product will be available when the applicable services/features are requested via the manual Local Service Request (LSR) process:

Package	USOC	Packaging IDs
BellSouth PreferredPack plan	PAMA5	COS-WW-PAMA5

The BellSouth PreferredPack plan consists of the Unlimited Residential Line with Touch-tone and Caller ID Deluxe, and at least two (2) of the following services/features where available:

- Call Waiting Deluxe
- Three-way Calling
- Privacy Director
- Call Return

The BellSouth PreferredPack plan also includes these additional features if Voice Mail is added:

- Call Forwarding Don't Answer
- Call Forwarding Busy Line
- Message Waiting Indicator
- Star 98 Access

Since the various services/features can be ordered individually, a-la-carte, the package USOC (PAMA5) and the desired services/features must be provided on the LSR to ensure proper handling of your Company's service request. To receive the discounted rate associated with the product package, the package USOC must be on the LSR in the FEATURE Section of the RESALE Form. In addition, to take advantage of the mechanized ordering charge, in the REMARKS section of the LSR, please note "Bill SOMEC Charge."

Additionally, in order to receive the discounted pricing plan, the appropriate Basic Class of Service associated with the BellSouth[®] PreferredPack[®] plan must be provided on the Resale LSR in the Feature details section:

Basic Class of Service- (choose one)

1F1CL – available in 8 states (Not available in North Carolina and Hernando, MS exchange)
PS1CL – available in North Carolina only (Except in the Gatewood and Milton exchanges)

Effective January 10, 2005, if all of the above information is not provided on the Resale Service form when ordering the BellSouth PreferredPack plan, the LSR will be returned for clarification.

Effective January 9, 2004, the following BellSouth PreferredPack plan packages were grandfathered and BellSouth will no longer accept new orders for these services or changes to these existing services:
