This is to advise that BellSouth has identified the following documentation defects in the LOH Version **13d** for TCIF 9 Release 13.0.

CCP Number	Description Of The Change
1279	Updated Business Rule # 3 to show for Manual Ordering only.
1686	CNAM Field (RS Form/screen) Updated Valid Entry Notes (Note 1) to change word from 'deviation' to "derivative".
1687	Updated the Data Dictionary [EATN field] stating EATN prohibited for ACT of N.

These changes will be reflected in the next update of the TCIF9 Release 13.0/LOH Version **13e** scheduled to be posted March 15, 2004.

ATN - Account Telephone Number (LSR form/screen)

Definition

Identifies the account telephone number assigned by the NSP. It is a dialable telephone number.

Definition Notes: None

Valid Entries

Manual: N = New Account Telephone Number or a valid Account Telephone Number Electronic: a valid Account Telephone Number

Valid Entry Notes

NOTE 1: Hyphens are automatically inserted by the BellSouth electronic interface system.

Data Characteristics

Manual: 1 alpha or 10 numeric characters (excluding optional hyphens) Electronic: 10 numeric characters

Manual: N or 2015551212 201-555-1212 Electronic: 2015551212

Conditional Usage

Note 1: When the REQTYP is B, NPT = D (LNP) and LNLN field is populated, this field is required.

Note 2: When the REQTYP is C, NPT = D (LNP) and the LNLN field is populated, this field is required.

Note 3: When REQTYP=E and the 4th character of TOS=W, then ATN is prohibited.

Note 4: When REQTYP=E and the 4th character of TOS=S, then ATN is prohibited.

Note 5: This field is required when the AN field on the LSR is not populated.

Business Rules

Rule 1: When (NON-COMPLEX) REQTYP E or M/ ACT =T this field is used to indicate the MAIN ACCOUNT NUMBER for the service at the NEW LOCATION. This field does not have to match the existing account number shown on the current Customer Service Record (CSR).

Rule 2: When the ATN is changing (ATN differs from existing account number), a DL page is required for any additional listings that include the existing account number (including foreign listings, alternate calls, etc.).

Rule 43: When EATN is populated, ATN cannot match EATN (REQTYP JB ACT=R).

Manual:

Rule 3-4: When REQTYP is E or M, ACT=C, LNA=X or REQTYP is E or M, ACT=V, LNA=G, V or X and the main account number is changing, the ATN field is populated with the new MAIN ACCOUNT TELEPHONE NUMBER.

Conditional Usage

Note 1: Prohibited when EAN, LEAN, or LEATN is populated. Note 2: Required when the LEAN, LEATN, or EAN are not populated and ACT is V, P, or Q. Note 3: Required when the EAN is not populated, and request is to change the telephone number(s) published in the

Directory when no provisioning required [REQTYP= J/ACT = R].

Note 4: Required when REQTYP A/ACT = V conversion from dial tone to EELs. Note 5: Required when REQTYP is E or M with ACT of T, and the EAN field is not populated.

Electronic:

Note 6: Required when REQTYP is E or M with ACT of T. Note 7: Prohibited when the ACT = N.

Business Rules

Rule 1: [BULK]

- For LSRs with a BOPI (UNE to UNE BULK request), SOMEC charges will apply.

- For LSRs with a BOPI (UNE to UNE BULK requests) , EATN must be all numerics.

- For UNE to UNE Bulk Migration, Required once per each UNE-P account to be migrated.

- For LSRs with a BOPI, all TNs associated with an EATN must be Porting.

- For Individual SUP LSRs with a BOPI , SUP 02 and 03 must be submitted on the individual LSR associated with the

specified EATN. Rule 2: [BULK] For UNE to UNE BULK requests, NAME EU will be Required per

each EATN. Rule 3: [BULK] For UNE to UNE BULK requests, a unique PON# is Required per

each EATN.
