This is to advise that BellSouth will complete deployment of ENCORE Release 18.0 and LNP Release 18.0 in CAVE on January 21, 2005. CAVE will be available for testing Release 18.0 beginning January 24, 2005. The 18.0 Telecommunications Access Gateway (TAG) Extensible Markup Language (XML) will also become available for testing on January 24, 2005. Please see the attached table for more details of the release.

In order to effectuate the implementation of the release, the CAVE environment will be unavailable for all testing from **January 18, 2005**, through January 21, 2005.
