Subject: CLECs – (Product/Service) – **REVISED** – Enhancement to the Access Daily Usage File

(ADUF) - Notification of Routing Determination on Exchange Message Interface (EMI) Detail

Records (Latest revision posted on April 8, 2005)

This is to advise that **effective April 14, 2005**, BellSouth will enhance the output provided from the Access Daily Usage File (ADUF) that is sent to Unbundled Network Element-Platform (UNE-P) and DS0 Wholesale Local Voice Platform (DS0 Platform) Services customers. Records output from the ADUF, after this enhancement is implemented, will reflect the addition of an originating or terminating Operating Company Number (OCN). The addition of the originating or terminating OCN will distinguish Local Exchange Carrier (LEC) calls from Interexchange Carrier (IXC) calls. LECs in this situation are defined as Incumbent Local Exchange Carriers (ILEC), Independent Companies (ICO), Facility-based CLECs and Wireless Service Providers (WSP). LEC calls include:

- Calls that originate from a UNE-P or DS0 Platform CLEC and terminate to a LEC.
- Calls that originate from a LEC and terminate to a UNE-P or DS0 Platform CLEC.

The enhancement will distinguish LEC originated or terminated calls from IXC calls as follows:

- For calls that originate from a UNE-P or DS0 Platform CLEC and terminate to a LEC, the UNE-P or DS0 Platform OCN will be populated in the Originating OCN field of the 11-0X-XX EMI record. The LEC OCN will be populated in the Terminating OCN field of the 11-0X-XX EMI record.
- For calls that originate from a LEC and terminate to a UNE-P or DS0 Platform CLEC, the LEC OCN will be populated in the Originating OCN field of the 11-0X-XX EMI record. The UNE-P or DS0 Platform OCN will be populated in the Terminating OCN Field of the 11-0X-XX EMI record.
- For calls that originate from a UNE-P or DS0 Platform CLEC and are carried by an IXC, the UNE-P or DS0 Platform OCN will be populated in the Originating OCN field of the 11-0X-XX EMI record. The Terminating OCN field will NOT be populated in the 11-0X-XX EMI record. The Carrier Identification Code (CIC) of the IXC carrying the call will be populated.
- For IXC carried calls that terminate to a UNE-P or DS0 Platform CLEC, the Originating OCN will NOT be populated in the 11-0X-XX EMI record. The UNE-P or DS0 Platform OCN will be populated in the Terminating OCN field of the 11-0X-XX EMI record. The CIC of the IXC carrying the call will be populated.
