The TNCAN-TN Query and TNAR-CAN Response should have been shown instead of the duplicate occurrence.
2282	Utilizing the acronym AHN (assigned house number): Remove all references to using @ symbol to identify unnumbered address from data dictionary. Added instructions detailing

how to populate LSR for unnumbered addresses utilizing the acronym AHN (assigned house number).

These changes will be reflected in the next update of the ELMS 6 Release 19.0/LOH Version **19.0c** scheduled to be posted Friday, September 9, 2005.

Partial Move Order Request - REQTYP E & M, Non-complex

Description:

A partial move request occurs when a customer is requesting to move lines from an existing account at one location to a new location, but wishes to leave at least one (1) working line at the old location.

Service Restrictions

- Limited to manual ordering
- Dual service is not applicable

LSR Considerations

The customer must submit multiple LSR packages and use the RPON and NOR fields to associate the LSRs.

- The first LSR should be submitted with an ACT C, LNA D for all lines that are moving to the new location, or are simply being disconnected at the time of the move.
- The second LSR should be submitted with an ACT N, LNA N for all lines that are being installed at the new service address. Additional lines (that did not exist at the previous address) may also be added on this LSR using LNA N.
 - The RPON field should be populated with the PON from the lead LSR, on all LSRs involved with the partial move request.
- The NOR field, for the lead PON, must be 01-XX, where XX is equal to the total number of LSRs involved with the partial move request. Each subsequent value for this field must be increased by one digit with XX data remaining the same.
- The customer should follow the REQTYP E (NON-Complex) R/C/O tables for ACT of C and ACT of N for completing an LSR for a partial move order on a resale account.
- The customer should follow the REQTYP M (Non-Complex) R/C/O tables for ACT of C and ACT of N for completing an LSR for a partial move order on Port/Loop combination residence/business.

ISDN-Basic Rate Interface (BRI) is a flexible high-bandwidth application for the transmission of voice, data, and video over a single facility. BRI is a digital service providing two 64 Kbps B channels (which transmit digital voice, video and/or data) and one D channel (which provides signaling for the service and supports 9.6 Kbps customer packet switched data).

ISDN allows you to integrate voice, data and video flexibly as the B channels can be carry voice conversations one second and provide Internet connectivity the second. By combining the two B channels (referred to as "bonding"), you can transport data at 128 Kbps, 2 to 3 times faster than today's fastest modems.

In addition, multiple phone numbers can be assigned to one ISDN line. For residential customers, ISDN-BRI offers a single solution providing multiple phone numbers and the speed to access the Internet or work from home.

- UNE-P/WLP Centrex is a measured rate service.

Telephone Number Assignment: Telephone numbers for these products are assigned to the Centrex, Common Block by CTX name, therefore telephone numbers may *not* be obtained from ATLAS. Telephone numbers inadvertently assigned from ATLAS by the CLEC may result in a clarification on or before the due date. Telephone numbers are not guaranteed until installed and working. **To obtain telephone number assigned to common block - contact your Local Support Manager (LSM).**

CAUTION

CLECs must provide all USOCs and FIDs associated with provisioning the UNE-P/WLP Centrex ports on Subsequent Service order activity i.e. CTX, CAT, SFG, DPG,CFNB, CFND etc.

When all ports at the service address (SA) main location of a UNE-P/WLP Centrex, BellSouth® Centrex®, ESSX®, and/or MultiServ®/MultiServ PLUS® account are being disconnected or moved this will result in a complete move of the system (T) order. The CLEC is responsible for initiating a service order to correct any information pertaining to the Company's Published Directory Listings that changes as a result of a Customer Control TN swap.

The CLEC will receive a FOC, and a unique PON will be assigned indicating the change was generated due to Customer Control referral.

Description

The unbundled loop/port combination UNE-P/WLP Centrex as developed consists of all necessary UNE elements when ordered will provide CLECs an end-to-end voice grade service for their end-users. The basic UNE elements associated with a single UNE-P/WLP Centrex are as follows:

UNE Loop: a 2 Wire Voice Grade non-design loop from the CLECs end user customer NID to the BellSouth local serving central office. In some instances where the CLEC's end user customer location is served from a different wire center than the Centrex Common block Serving Wire Center a 2 Wire Voice Grade Design Loop will be utilized.

2-Wire Voice Grade port (Centrex): There is one associated BellSouth Centrex Switch port for each 2 Wire Voice Grade Loop. Each 2-Wire Voice grade port (Centrex) provides access to the Centrex features. Features available to each station vary depending on the type of switch in the serving central office. The availability of features and/or restrictions must be identified at the time of ordering Features inherent to the switch and switch software not currently being used or not purchased by Bellsouth may still be available to the CLEC through the Bona Fide Request (BFR) process.

A common Block Program: Within the BellSouth Switch the 2-wire voice grade ports (Centrex) are programmed into a common block of numbers which will partition the switch to serve a specific customer and as such share certain inherent Centrex functionalities, capabilities, and features. The Common Block program is also known as the "Common Bock" or the "Centrex Customer Group". The Unbundled Centrex Common Block defines system level parameters giving the Centrex virtually unlimited growth. Common equipment parameters offer the minimum capabilities of the system.

Network Access Registers: A NAR is associated with access outside of the Centrex system. Each NAR provides a single talking path to the public switched network or a private network. A NAR can be inbound, outbound or combination. All unbundled ports are subject to Unbundled Switching and to Local Interconnection Usage charges. These charges will apply to each port/loop combination of UNE-P/WLP Centrex. Consequently, other than to limit access to the Public Switched Network, NARs are on to a necessary network element of UNE-P/WLP Centrex. During the conversion process all NARs will be retained as is from the converted BellSouth service. NARs will be zero rated on the CLEC Account. Subsequent, rearrangements, additions, or removal of NARs will incur the appropriate subsequent activity charges (the USOC URECA should be used) per





request. New installations can be provisioned with or without NARs at the request of the CLEC.

- UARCX combination NARs (2 Way Measured)
- UAR1X Incoming NARs (1 Way Incoming Measured)
- UAROX Outgoing NARs (1 Way Outward Measured)

DID Resale

Direct Inward Dialing (DID) service is an inward only, trunk side service that enables customers to have fewer DID trunks/NARs than telephone numbers, while bypassing the PBX attendant.

With Non-DID PBX Service, inward or combination trunks originate in the central office and terminate in the customer's PBX common equipment. The PBX equipment generally switches each call to the PBX attendant, who screens the call and transfers it to the desired station.

With DID service, each PBX station to be dialed directly is assigned a seven-digit exchange telephone number. When one of these DID numbers is dialed directly, the central office equipment:

- Determines the signaling needed by the PBX
- Determines the number of digits to send
- Determines the trunks/NARs for sending the message
- Routes the incoming call to an inward trunk
- Passes dialed digit information to the customer's PBX so that the PBX may route the call directly to the desired station.

There are three major components of DID service:

- DID numbers (sold in blocks of 20)
- DID trunks or NARs
- DID terminations (one per DID trunk or NAR).

DID numbers and DID trunks are combined to provide DID Service. The number of DID trunks per DID station is dependent on the volume of anticipated incoming traffic. If the customer wants a combination of DID trunks and other trunks that go to an attendant, two or more Trunk Groups must be arranged.

A customer who anticipates growth may also reserve blocks of DID numbers. For example, if the customer's working DID numbers range from 6500 to 6559, the customer may wish to reserve two more blocks of 20 numbers, 6560 to 6599, so that their DID numbers may remain consecutive as the business grows. Rules and billing for reserved numbers vary by state. Refer to the State Tariffs for additional information.

DID is generally available in most central offices; however PSIMS should be checked for available facilities and the CRSG will provide the Route Index and Trunk Group Number





required for ordering and provisioning. The customer is responsible for providing interception of calls to vacant or non-working assigned DID numbers.

When ordering new DID arrangements the customer must provide the following:

Type Of Start Dial Signal:

- Wink Start: The PBX can identify the first 3 or 4 digits of the station number being accessed. In order to identify the last 3 or 4 digits the central office must signal back to the PBX to prepare to accept these digits. The PBX then signals back to the central office to send the digits
- Immediate Start: As soon as the central office seizes a trunk, the central office machine immediately sends the called station digits back to the PBX for decoding
- **Delay Dial:** Same as Wink Start except signals are not used. Delayed time intervals are used in place of signals to perform the identification process.

Other Optional Types Of Signaling:

- **Dial Pulse:** transmits pulses that equate to rotary dial service. This is an automatic default that does not require an additional USOC
- Multi-Frequency: transmits tones that are similar to TouchTone.
- **Dual Tone Multi-Frequency:** transmits faster TouchTone signaling than Multi-frequency.

Private Branch Exchange service (PBX) Resale Service

Resale Services are those bundled services where the service provider is different from the network provider. Competitive Local Exchange Carriers (CLECs) can purchase telecommunications products, features and services from Local Exchange Carriers such as BellSouth®, for resale to their customers.

Private Branch Exchange Service, commonly known as PBX Service, provides various arrangements of switching and control equipment connecting users to local, long distance and private networks in addition to supporting communication between station users. The PBX System switching and control equipment is located on the customer side of the network interface. The customer is responsible for ordering services and options that are compatible with their PBX switch and maintaining hardware and software changes from the Network Interface to the PBX Switch as needed.
