Guidelines for the New BellSouth® 2 Pack Plan for Manual Ordering Only

(Originally posted on November 4, 2005)

This is to advise on November 1, 2005, BellSouth implemented the BellSouth[®] 2 Pack Plan, a new vertical service package, which is available to Resale CLECs **only** on a manual ordering basis **for all activity types.** However, this service is not available in Desoto County, Mississippi.

The following Uniform Service Order Code (USOC) and Field Identifier (FID) for this new product will be available when the applicable services/features are requested via the manual Local Service Request (LSR) process:

Package	USOC	Packaging IDs
BellSouth 2 Pack Plan	PAMA6	COS-WW-PAMA6

The BellSouth 2 Pack Plan consists of the Unlimited Residential Line with Touch-tone, Caller ID Deluxe and Call Waiting Deluxe.

The BellSouth 2 Pack Plan may also include the following Voice Mail Companion Services when BellSouth Voice Mail is chosen:

- Call Forwarding Don't Answer
- Call Forwarding Busy Line
- Message Waiting Indicator
- Star 98 Access

Because the various services/features can be ordered individually, a-la-carte, the package USOC, PAMA6, and the desired services/features must be provided on the LSR to ensure proper handling of your company's service request. Listed below are additional ordering guidelines:

- To receive the discounted rate associated with the product package, the package USOC must be on the LSR in the FEATURE Field in the Service Details Section of the RESALE Service Form.
- To take advantage of the mechanized ordering charge, "Bill SOMEC Charge" must be noted in the REMARKS section of the LSR.

 In order to receive the discounted pricing plan, the appropriate Basic Class of Service associated with the BellSouth 2 Pack Plan must be provided on the Resale LSR in the Feature details section:

Basic Class of Service- (choose one):

1F2CL – available in all states except North Carolina
PS2CL – available in North Carolina only

If all of the above information is not provided on the Resale Service form when ordering the BellSouth 2 Pack Plan, the LSR will be returned for clarification.

On **March 3, 2006**, the General Section of the Local Ordering Handbook (LOH) will be updated with Release 21.0B. The new requirements in the Feature Section of the LSR as outlined above will be included in that update of the LOH. Please use the ordering guidelines listed above until the update occurs.
