Subject: ATM and Frame Relay IXCs – (Tariff) - Tariff Filing for Fast Packet Access Services

This is to advise on March 2, 2006, BellSouth will file revisions to its BellSouth Tariff FCC No. 1, Sections 2, 21 and 23 for Fast Packet Access Services, to delete an existing service, make revisions to terms and conditions, and make minor rate changes. This tariff is scheduled to become effective on March 17, 2006.

Listed below are the changes associated with this filing:

- November 1, 2005, BellSouth filed a Section 214 Application to request authority to discontinue the provision of Exchange Access Connectionless Data Service (XACDS). On January 17, 2006, the Application was granted. Therefore, with this filing, the XACDS in Sections 21 and 23 are being deleted, along with any miscellaneous references to XACDS in the Table of Contents or in Sections 2 and 21.
- BellSouth is placing language in Section 21 for the Exchange Access Asynchronous Transfer Mode Service (XAATMS) and Managed Shared Asynchronous Transfer Mode Service (MSATMS) to provide a description of the service that the existing Flat Rate Variable Bit Rate (VBR) elements provide. Such descriptions were inadvertently left out of Section 21 when the rate elements were introduced.
- Rate corrections are being made in Sections 21 and 23 for Managed Shared Frame Relay Service (MSFRS) Connection month-to-month rate elements for 24 Mbps and 27 Mbps User Network Interface (UNI) and Network-to-Network Interface (NNI) Extended Connections applicable where the serving wire center of the customer premises is over 125 miles outside of the MSFRS Service Area.
- Customers with Exchange Access Frame Relay Service (XAFRS), XAATMS, MSFRS and MSATMS will need to submit orders to request BellSouth to rearrange their existing service to a different packet switch. This action is necessary for XAFRS and XAATMS customers in order to redesign or groom their networks. Additionally, this action is necessary for XAFRS, XAATMS, MSFRS and MSATMS customers in order to have access to optional service features that may be available from a different packet switch. BellSouth is adding clarifying language in Section 21 for these individual services: XAFRS, XAATMS, MSFRS and MSATMS, regarding the appropriate rating and provisioning for such requests.
