Description:

REMOTE ACCESS - CALL FORWARDING (RACF)

Remote Access - Call Forwarding includes the basic feature, Call Forwarding Variable (CFV). It allows the customer to forward calls from their home telephone or from another line when away from home using Touch-Tone signaling.

Remote Access - Call Forwarding (RACF) is:

- available in all central offices
- able to be activated or deactivated from any location
- flexible in that forward to number can be changed from any location
- eligible for Multi-Feature Discount Plan
- forwarded only to the primary number in a RingMaster group

The USOC for RACF is GCZ.

FIDs that may be used with RACF include:

- MCFI used when the customer wants only the main number to call forward. Reference RingMaster Section - FID Analysis and Mapping Sheet for MCFI for a more detailed description of this FID.
- NCF (Multipath) can be used to indicate number of calls forwarded.

PID – unique 4 character numeric code used to access and setup RACF remotely.

Restrictions

The Business Flat-Rate Multi-line USOC does not apply to the following types of customers:

- Single Line Business Customers
- MultiLine Business Customers who have the following types of service:

 - Business Plus, Options 1 or 2 (BD1, BD1CL, BD2, BD2CL)
 Complete Choice for Business (PKG FID) lines inside the package
 1FB Customer with Complete Choice (PKG FID)

The Business Flat Rate Multi-line USOC does not apply to the following types of lines:

- Back-up Lines (SBL++).
- Measured Rate Lines (1MG & 1MH).
- Message Rate lines (1MB).
- Extended Area Calling Plans.
- Foreign Exchange (FX) and Foreign Central Office (FCO).

Non-Published (Private) Listing (NP)

A non-published listing is not listed in either the alphabetical section of the directory or directory assistance records. See the Tariff for the situations where Non Published listings are provided at no recurring charge. Enter the appropriate USOC in the FEATURE field of the Resale Service (REQTYP E) or Port Service (REQTYP M) form when including listing instructions to order a Non Published Listing.

Non-Published Listing with no recurring charge

Customers are eligible for a non-published listing with no recurring charge when the following criteria is met:

 Must have other <u>listing(s)</u> in the exact same exchange, with the exact same listed name on an existing CSR billed to the CLEC submitting the LSR.

Deleted: working service

When the criteria above is met and the customer wishes a non-published listing with no recurring charge the customer should include the following information to uniquely identify the request:

TCIF 9

Not applicable to REQTYP B, C or J.

Populate the following: NP3 in the FEATURE field.

- LTY must be 3
- System verifies eligibility.

ELMS6

- If requesting NP3 (non-published listing with no recurring charge), populate EOS with the other listed service tel.no.
- System verifies eligibility
- NP3 is not required in the feature section
