This is to advise that, on May 25, 2006, BellSouth will complete deployment of ENCORE Release 22.0 and Local Number Portability Release 22.0 (LNP) in CLEC Application Verification Environment (CAVE). CAVE will be available for testing Release 22.0 beginning May 25, 2006. The 22.0 Telecommunications Access Gateway (TAG) Extensible Markup Language (XML) will also become available for testing at that time.

In order to effectuate the implementation of the release, the CAVE environment will be unavailable for any CLEC testing from May 18, 2006 through May 23, 2006.
