This is to advise that BellSouth will implement the following changes to update documentation in the LOH Version 22.0 for ELMS 06, Release 22.0.

	(PLS is required when the LVL field is different than the value in the DOI field. Otherwise the system will generate an error message.)
2366	Line Splitting Remote Site HFS Unbundled Without Loop Modification DLEC Owned & BST Owned Splitter: Change QTY from '5+' to "10+" for quantities 9 or greater for Line Splitting Remote Site HFS Without Loop Modification DLEC Owned & BST Owned Splitter interval.
2367	BCS Field on LSR: Deleted Valid Entry Note 6, no longer applies.
2368	MI field for EEL to UNE and SPA to UNE conversions: Updated Conditional Usage Note 1 to indicate that the MI field is not needed on EEL to UNE or SPA to UNE Conversions.

Rule 8: In accordance with the Triennial Review Remand Order (TRRO), effective April 17, 2005, for REQTYP = N, UNE-P/WLP 2-Wire Direct Inward Dial (DID) Trunk Port and Voice Grade Loop Combination (UNE-P/WLP 2-wire DID), BellSouth will no longer accept orders for ACT = N, and V and ACT = C when TNA = N or TACT = N, when requesting new UNE-P without having negotiated a current Commercial Agreement. This ruling applies only in the states of Georgia, Florida, Mississippi, and North Carolina. This ruling will be effective in Kentucky on April 27, 2005.
