Subject: All Interconnection Services Customers – (Network Operations) - Sale of Lucent No. 5ESS Switch for Redstone Arsenal Central Office in Huntsville, Alabama, to the U. S. Army

Pursuant to BellSouth's Network Disclosure No. 20050147, dated September 13, 2005, this is a reminder that, on Saturday, April 22, 2006, at 12:01 AM CDT, the Lucent No. 5ESS switch for Redstone Arsenal, Common Language Location Identification (CLLI) HNVIALRADS0, in Huntsville, Alabama, will be sold to the U. S. Army and will become a customer premises PBX. Since Redstone Arsenal will no longer be a Central Office (CO), all traffic terminating to that CO must be redirected to the Huntsville-Parkway No. 5ESS switch (HNVIALPWDS0). The point code for the switch accepting the new traffic is 252 137 003.

In addition, the Redstone Arsenal (HNVIALRADS0) switch has an optical Remote Terminal (RT), HNVIALSDRS0, located at 106 Wynn Drive. The RT will also be replaced, on April 22, 2006, by a Digital Loop Carrier (DLC) System. These lines will be transferred to the Huntsville-University Data Management System (DMS) switch (HNVIALUNDS0). The point code for the switch accepting these lines is 252 137 005.

The following NXX codes will be affected by the actions listed above:

Area Code: 256

NXXs: 313, 450, 842, 876 and 955

After traffic has been redirected from both the Redstone Arsenal and Wynn Drive switches, each will be removed from the BellSouth network and decommissioned. Facilities served by the Redstone Arsenal switch will become the property of the U. S. Army. BellSouth will provision services to Redstone Arsenal from Huntsville-Parkway CO, using fiber optic and subscriber carrier facilities. No copper facilities will be available.

Interconnecting carriers with existing trunk groups to the end office on Redstone Arsenal (HNVIALRADS0) must move all facilities to the new Huntsville-Parkway (HNVIALPWDS0) host switch. To ensure a smooth transition, BellSouth has provided interconnecting carriers with Trunk Group Service Request Forms (TGSR).

The Redstone Arsenal CO is now in a service order freeze and will continue through April 26, 2006. After that date, BellSouth will process service orders, including Point of Presence (POP) moves, major trunking rearrangements, translation changes or critical dates, up to the point of demarcation.
