Subject: CLECs – (Documentation/Guides) - Update to the BellSouth Local Ordering Handbook (LOH) Version 22.0A, New Local Service Ordering Guide 6 (LSOG 6) and EDI Local Mechanization Specifications 06 (ELMS 06) for Release 22.0

This is to advise that BellSouth will implement the following changes to update documentation in the LOH Version 22.0A for ELMS 06 Release 22.0.

# DFDT

Desired Frame Due Time LSR Form / Screen LSOG6 / ELMS6

### Definition

Identifies the desired frame cutover time.

### **Definition Notes**

Note 1: The time indicated in this field will reflect the local time of the end user's location(s).

#### **Conditional Usage Notes**

Note 1: This field is prohibited when the ACT is N, except for REQTYP A Transport Products when a hot cut is being requested with ACT = N and ACT = D LSRs.

- Note 2: Prohibited when the REQTYP is A and the ACT = C, D, or T, except for REQTYP A Transport Products when a hot cut is being requested with ACT = N and ACT = D LSRs.
- Note 3: Prohibited when the REQTYP is E (Non-Complex) or M (Non-Complex).
- Note 4: Prohibited when the REQTYP is E with 2nd character TOS of H and the ACT is C, D, T, V or W.
- Note 5: Prohibited when the REQTYP is N and the ACT is W.

- Note 6: Prohibited when the CC or NNSP field is populated with a wireless OCN.
- Note 7: Prohibited when the REQTYP is A for ACT=V and the product is Digital Data Designed (DS0)

- Note 8:
   [BULK Option 1 and Bulk Single LSR Arrangement Option 2] Prohibited when the BOPI field is populated.

   Prohibited when the request is an LNP to Resale UNE-P/WLP Migration for REQTYP E, M, P and N. And when the SC field is "LCSL".

- Note 10: Required when REQTY is E (Complex) and the Act is C or V for Frame Relay with speed changes.

### **Business Rules**

- Rule 1: For projects, frame due times are negotiated with the CLEC.
- Rule 2: For non-projects, frame due time indicates the specific time the request is to be worked.
- Rule 3: When the CHC is populated and the DFDT is populated, the DFDT field must be a single entry; of an hour and minute and not a span of time.
- Rule 4: When DFDT is populated with a time requested for time specific hot-cut, the time requested may be changed by BST to the next available time slot. This time slot assignment may be the same day or next business day. If assigned a different time and/or due date, the changed appointment will be reflected in the FOC.
- Rule 5: When the REQTYP is A or B, and the information populated in the NC field begins with TY or TX, the CHC field is also required.

### Manual

Rule 6: For REQTYP A Transport Products: Non-Channelized DS3, STS-1 and IOC, Unbundled Dark Fiber (UDF), Ordinarily Combined UNEs (OCU) and EELs, Commingled Non-Channelized DS3, STS-1 and IOC connected to Wholesale, Commingled Ordinarily Combined UNEs (OCU) and EELs connected to Wholesale, and Single bandwith Commingled, if a hot cut is being requested with ACT = N and ACT = D LSRs a specific time may be entered in the DFDT field. The N and D LSRs must also be RPON'd.

Note 1: Required when the 2nd character of the TOS is P.

NOTE 2: For REQTYP A & B, LSP AUTH is required when the CFA or Cable ID / Chan Pair belongs to another CLEC than the one submitting the LSR and a Blanket LOA is not attached to a manual LSR.

### **Business Rules**

<u>Manual</u>

- Rule 1: Optional when the REQTYP is A and the NC Code begins with LY\*\*, LX\*\*, HC\*\* or TY\*\* and a signed Blanket LOA agreement is on file.
- Rule 2: Required when Third Party Collocation is requested and an individual LOA is not submitted with the LSR.
- Rule 3: Prohibited when the product being requested is IOC, EEL or Ordinarily Combined UNE.
