This is to advise that BellSouth will deploy ENCORE Release 22.0 on July 8, 2006 through July 9, 2006. The Electronic Data Interchange (EDI), Local Exchange Navigation System (LENS) and the Telecommunications Access Gateway (TAG) systems will be unavailable for Local Service Request (LSR) processing beginning on Saturday, July 8, 2006 from 9:00 PM EDT until Sunday, July 9, 2006 at **12:00 PM** EDT.

The Local Number Portability (LNP) **Gateway**, including Wireless LNP, will be unavailable for LSR processing beginning on Saturday, July 8, 2006 11:00 PM EDT until Sunday, July 9, 2006 **12:00 PM** EDT. No routine porting activity involving a Service Order Activation (SOA) notification or Local Service Management System (LSMS) broadcast, including Creates, Subscription Version (SV) and Pooled Blocks Activates, Modifies, Disconnects, Audits and Recovery will be performed during the system downtime.

The Fax Server for submitting manual LSRs will be unavailable **beginning on Saturday, July 8, 2006** from **9:00 PM** EDT until Sunday, July 9, 2006 at **12:00 PM** EDT.

Telephone access to the BellSouth Local Carrier Service Center (LCSC) will be normal business **operating hours**.

CLECs are also reminded that Telecommunications Industry Forum 9 (TCIF 9) will be retired with the Implementation of EDI Local Mechanization Specifications Version 10 (ELMS 10) in ENCORE Release 22.0. Please refer to Carrier Notification letter SN91086097, **posted on May 11, 2006**, for **additional** details.
