This is to advise that BellSouth will implement the following changes to update documentation in the LOH Version 22.0C for ELMS 10 Release 22.0.

2399	AN field (LSR Form/Screen) correction for REQTYP BB: Update Valid Entry Notes (Manual) Note 2 to read: "When REQTYP B or C, NPT is D (LNP) the valid entry of N is prohibited."
2401	Ordering Guidelines for BellSouth Preferred Package: Updating BellSouth Preferred Package (titled: Ordering Guidelines for BellSouth® 2 Pack Plan) verbiage to remove references to 'Milton NC' and 'Gatewood NC'.
2403	ORDN Field (End User Form/Screen); Add TOS Values to ORDN Conditional Usage Notes.
2407	BAN1 field (LSR Form/Screen) for REQTYP A Non-Designed: Updated Valid Entry Note 1 and Business Rule 5 to include additional non-designed NC (Network Channel) Codes.

# AN

Account Number LSR Form / Screen LSOG10 / ELMS10

### Definition

Identifies the main account number assigned by the NSP.

#### **Definition Notes**

- Note 1: Identifies a non-standard account number.
- Note 2: Identifies an account number that is not a dialable number (e.g., miscellaneous account number).
- Note 3: Use this field when listing request is for an 800 service listing or an interstate foreign listing or foreign listings in independent territories.

- N = New Account Number

### Valid Entry Notes

Note 1: Hyphens are automatically inserted by the BellSouth electronic interface system. <u>Manual</u>

Note 2: When REQTYP **<u>B</u> or** C, NPT is D (LNP) the valid entry of N is prohibited.

## Conditional Usage Notes

- Note 1: Excluding REQTYP C, required when the ATN field is not populated.
- Note 2: For REQTYP C, the AN field is required when interstate foreign listing is requested.
- Note 3: Prohibited when the REQTYP is J with ACT of R and the EATN field is populated.

#### **Business Rules**

- Rule 1: A CABS billing account number is valid only when the REQTYP is A or B.
- Rule 2: For REQTYP J, with ACT of D, when this field is populated the class of service on the Customer Service Record (CSR) must be MSA or MHT.
- Rule 3: The same Miscellaneous Account number cannot be assigned for different end users.
- Rule 4: When REQTYP is A or B (Designed Loops) the AN and BAN1 fields must match.
- Rule 5: When the REQTYP is A or B (designed) loops, this field is to be populated with the CABS account number.
- Rule 6: When the REQTYP is A or B (non-designed) loops, this field is to be populated with a CRIS miscellaneous account number.
- Rule 7: When the REQTYP= A (Designed Loops) and the ACT = W, the data in the AN field cannot match the data in the EAN field.
- Rule 8: When the REQTYP= A (Designed Loops) and the ACT = W, the system will validate that the first 10 characters of the AN field is a valid working CABS account.
- Rule 9: When the REQTYP= A (Non-Designed Loops) and the ACT = W, the system will validate that the first 10 characters of the AN field is a valid working CRIS account.
- Rule 10: When the REQTYP= A (Non-Designed Loops) and the ACT = W, then the first 10 characters of the AN field must match the first 10 characters of the EAN field number of characters.

#### <u>Electronic</u>

Rule 11: [Bulk Single LSR Arrangement] For LSRs with a BOPI, the Account Number is required once for each EATN.

Rule 12: (ULUE)-For LSRs with a BOPI, the AN field is required once for each ECCKT.

### Conditional Usage Notes

Note 1: For RETYP E or REQTYP M (Non-Complex), with a TOS = 1AF-, 1BF-, 2AF-, 2BF- 1AM-, 1BM-, 2AM-, or 2BM-, when the ACT is N or T, or ACT = V and MI = A, or C, and the state is Mississippi, and the word ORDINANCE is present in the Service Instruction field in RSAG, the ORDN is required.

Note 2: ORDN is prohibited in all states except Mississippi.

Note 3: For RETYP E or REQTYP M (Non-Complex), with a TOS = 1AF-, 1BF-, 2AF-, 2BF- 1AM-, 1BM-, 2AM-, or 2BM-, when the ACT is N or T, or ACT = V and MI = A, or C, and the state is Mississippi, and the word ORDINANCE is not present in the Service Instruction field in RSAG, the ORDN is prohibited.

Note 4: For RETYP E or REQTYP M (Non-Complex), with a TOS = 1AF-, 1BF-, 2AF-, 2BF- 1AM-, 1BM-, 2AM-, or 2BM-, when the ACT = V and MI = B, or D, and the state is Mississippi, the ORDN field is prohibited.

Note 1: For REQTYP A (excluding Line Share) where the first two characters of NC do not equal TY or TX the 4TH character of BAN1 must be N.

Note 2: For REQTYP A (Line Share) 2ND character of TOS equals "R" the 4th character of the BAN1 field must be "C".

### **Conditional Usage Notes**

- Note 1: For REQTYP C, ACT = V, ELT = A or C, the BAN1 field is required.
- Note 2: For REQTYP C, ACT = V, when request is WLNP, CC, or NNSP = wireless OCN, and the ELT = A or C, the BAN1 field is required.
   Note 3: For REQTYP C, ACT = V, when request is WLNP, CC, or NNSP = wireless OCN, and
- the ELT=B, the BAN1 field is not required.
- Note 4: For REQTYP C, ACT = V, when the ELT = B the BAN1 field is not required.

### **Business Rules**

- Rule 1: BAN1 and BAN2 when populated must not match.
- Rule 2: Billing Account(s) must be established prior to submitting any service request.

- Rule 3: For REQTYP A and B when the NC does not begin with TY or TX and the 2nd character of the TOS is not P, this field must be the CABS account number based on
- Rule 4: For REQTYP B when the NC begins with TY or TX, this field is populated with either the Q account for the Loop or the master Q account for Interim Number Portability
  Rule 5: For REQTYP is A, (excluding Line Share), where the first two characters of NC do not = TY or TX
- the BAN1 must match the account number in the AN field.
- Rule 6: The CC (Company Code) on the LSR must always match the CC on the Billing
- Account (BAN) on the LSR. (This Rule does not include REQTYP A Line Splitting and Rule 7: The CCNA and ACNA on the LSR must always match the CCNA and ACNA on the
- BAN. (This Rule does not include REQTYP A Line Splitting.)
- Rule 8: When the NNSP/CC is for a wireless carrier the NPA NXX of the BAN1 account must equal the same Revenue Account Office (RAO) of the ported telephone number(s).
- Rule 9: When the request is WLNP, CC or NNSP = Wireless OCN, and the BAN1 is populated, this field must be populated with the valid wireless miscellaneous billing account number for the recipient provider.

#### <u>Electronic</u>

- Rule 10: [Bulk Single LSR Arrangement] For REQTYP B Single LSRs in a BULK Arrangement this field is required once per EATN.
- Rule 11: BAN must match correct site and RAO for REQTYP requested.
- Rule 12: BAN1 and BAN2 when populated must not match.
- Rule 13: If REQTYP = A (Designed Loops CABS billed), E (Non-Complex) or M (Non-Complex) and if ordering Network Interface Devices or Outside Rearrangement populate with the CLEC Master Q Account Number in the BAN2 field.
- Rule 14: When REQTYP is B and the request include listings, the BAN1 field should be populated with the Loop billing account number and the BAN2 field should be populated with the Number Portability billing account number.
- Rule 15: When the request is WLNP and the CC or NNSP field is populated with a wireless OCN and the ELT = A or the LACT = Z the service address for the Directory Listings will default to the address on the CSR for the WLNP billing account number indicated in the BAN1 field.
- Rule 16: When the request is WLNP, WLNP, CC or NNSP = Wireless OCN the 4th character of this field must not be Q.

#### <u>Manual</u>

- Rule 17: (ULUE) Required once per ECCKT.
- Rule 18: When the request is WLNP, WLNP, CC or NNSP = Wireless OCN, the 4th and 5th character of this field must not be Q.
