Due to action taken by the Louisiana Public Service Commission (LPSC), calls made over AT&T facilities between the following communities will become toll free as of June 26, 2007:

Blanchard to and from Benton and Haughton

When the local calling areas for these communities are expanded on June 26, 2007, AT&T customers, including Resale and Pay Telephone Access Service (PTAS) customers, will no longer be charged toll charges for calls between these communities. Effective June 26, 2007, all calls between these communities must be dialed on a seven-digit basis.
