Due to action taken by the Louisiana Public Service Commission (LPSC), calls made over AT&T facilities between the following Louisiana communities in the 337 area code will become toll free as of July 17, 2007:

Crowley, Eunice, Gueydan and Rayne become local to each other;

Additionally, calls between these four (4) calling communities and the Lake Arthur and Jennings communities will also be toll free.

When the local calling areas for these communities are expanded on July 17, 2007, AT&T customers, including Resale and Pay Telephone Access Service (PTAS) customers, will no longer be charged toll charges for calls between these communities. Effective July 17, 2007, all calls between these communities must be dialed on a seven-digit basis.

Following is a chart listing the first three digits (NXX) of the telephone numbers included in the expanded local calling areas for these Louisiana communities in the 337 area code.
