The Local Number Portability (LNP) Gateway, including Wireless LNP, will be unavailable for LSR processing on Saturday, July 7, 2007 from 9:00 PM EDT until Sunday, July 8, 2007 at 12:00 Noon EDT. No routine porting activity involving a Service Order Activation (SOA) notification or Local Service Management System (LSMS) broadcast, including Creates, Subscription Version (SV) and Pooled Blocks Activates, Modifies, Disconnects, Audits and Recovery will be performed during the downtime of these systems.

The Fax Server for submitting manual LSRs will be unavailable on Saturday, July 7, 2007 from 9:00 PM EDT until Sunday, July 8, 2007 at 12:00 Noon EDT.

Telephone access to the AT&T Local Carrier Service Center (LCSC) will be normal business operating hours.
