#### **NPA Split Alternatives**

### I. Split at Louisville / Owensboro LATA Boundary

NPA # 1 - The Louisville LATA has 305 central office codes assigned as of October, 1997. Major exchanges in the Louisville LATA include:

NPA #2 - The Owensboro LATA has 231 central office codes assigned as of October, 1997. Major exchanges in the Owensboro LATA include:

Bowling Green (16 codes) Madisonville (8 codes) Henderson (11 codes) Owensboro (13 codes) Hopkinsville (6 codes)Paducah (16 codes)

#### II. Louisville Extended Local Calling Area

The exchanges included in the northeast portion of the Louisville LATA and the area included in the Kentucky Area Calling Service plan for the LaGrange, Louisville, and West Point exchanges will comprise NPA #1.

NPA #1 - Some exchanges proposed for inclusion in NPA #1 are:
