Preface

The information contained within this document is an AT&T Southeast Region customized version of the Ordering & Billing Forum (OBF) industry consensus guidelines. The rules contained within this document are AT&T-SE specific and have been modified to accommodate local order processing within AT&T-SE.

This document addresses the processes and business rules for **Local** Service Requests (LSR) only. AT&T Southeast Region offers additional services (such as Local Interconnection Trunking) to Facility Based CLECs through the **Access** Service Request (ASR). For more information on ASRs, refer to the *Access Service Ordering Guidelines* (ASOG) and the *Guide to Interconnection*. The ASOG is published by the Alliance for Telecommunications Industry Solutions (ATIS) and is available at the ATIS web site: http://www.atis.org

Purpose

The purpose of this document is to:

- Provide local service ordering instructions for CLECs that offer local telecommunications services utilizing Resale Services or Unbundled Network Elements (UNEs).
- Provide a common point of reference to simplify the manual and electronic ordering processes for CLECs that conduct business with AT&T-SE and have converted to ELMS Issue 10 and/or LSOG 10.

A manual process entails submitting Local Service Requests via a 22-state AT&T Manual LSR forms (by Email). It is highly recommended that CLECs have access to the Internet and the World Wide Web as AT&T Southeast Region provides a wealth of information to its customers in this format and much of this document is used in conjunction with other documents that are posted on the Internet for the CLECs' convenience.

An electronic process entails submitting Local Service Requests via an AT&T Southeast Region approved electronic interface. More information on the electronic interface options available to CLECs can be found at http://wholesale.att.com.

This document provides detailed information generally applicable in the nine states served by AT&T Southeast Region. Description:

Local Ordering Handbook (LOH) guidelines incorporate the following requirements for the population of fields:

- **Required** is defined as the field *MUST* be populated and when populated incorrectly/incompletely, the LSR will be clarified.
- Conditional is defined as the *field is <u>dependent</u> upon the relationship to another entry* as specified in the usage statement and is *dependent upon the presence*, *absence or combination of other data entries* and if populated incorrectly/incompletely, the LSR may be clarified.
- **Optional** is defined as the field *may or may not* be populated and if populated incorrectly/incompletely, the LSR may be clarified.
- Not Supported is defined as this field *is not used by AT&T Southeast Region* and when populated will be ignored by AT&T Southeast Region. The Not Supported fields will not be shown in the Required, Conditional and Optional (R/C/O) tables, but will be reflected in the Local Service Ordering Requirements (LSOR).
- **Prohibited** is defined as this field *must NOT* be populated and when populated, the LSR will be clarified by AT&T Southeast Region. The Prohibited fields are not shown in the Required, Conditional and Optional (R/C/O) tables, but 'prohibited' occurrences are defined in LSOR.
