
Dear Ms. Tanner:

Pursuant to Section 4.5.2 of AT&T Georgia Self-Effectuating Enforcement Mechanisms Administration Plan ("SEEM Plan"), AT&T Georgia declared a force majeure event that began August 30 in connection with Hurricane Idalia.

As of the end of business on September 6, 2023, AT&T Georgia hereby lifts the force majeure declaration for this event for all Service Quality Measures ("SQMs") associated with Provisioning Maintenance & Repair, and Trunk Group Performance measures.
