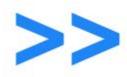




Prior to getting into detail, it is important to have a basic understanding of what the Wireless Ordering System (WOS) is:

- The Wireless Ordering System Implementation is an initiative to deliver a webbased ordering system for BellSouth's ICS wireless customers (carriers) to enhance the ordering experience and streamline the current process.
- In addition, the WOS project will deliver a web-based internal interface and Business Process Management solution to drive the methods and procedures that Center, Account Teams and Staff Support will use in support of this mechanized solution.









Before learning more about the WOS, it is important to associate yourself with the following terms:

- BPM Provides the ability to manage complex order processing flows. Directs internal users to interact with the system when WSRs need additional information.
- Common Language Location Identifier (CLLI) Common language code that identifies individual locations of a physical plant. A CLLI is composed of 11 alphanumeric characters, which serve as a substitute for a street address and room number of an access customer or local exchange company location. The character position of the CLLI code is as follows: the first 4 codes represent the place abbreviation, codes 5-6 denote the state abbreviation, codes 7-8 denote the building identification, and codes 9-11 denote specific equipment identification.
- Wireless DS1 Circuit connecting one office to another via the BellSouth network.
- Wireless Integrated Processing System (WIPS) A BellSouth legacy system that interacts with WOS, RSAG, SOCS and PSIMS.





Before learning more about the WOS, it is important to associate yourself with the following terms:

- Wireless Order Service Order Generator (WOSOG) Separate component that actually builds the Wireless Service Requests.
- Wireless Ordering System (WOS) The wireless ordering system is an initiative to deliver a web-based ordering system for BellSouth's ICS wireless customers (carriers) to enhance the ordering experience and streamline the current process. In addition, the project will deliver a web-based internal interface and Business Process Management solution to drive the methods and procedures that Center, Account Teams and Staff Support will use in support of this mechanized solution.
- Work Fallout Occurs when a condition exists that triggers manual processing of a Wireless Service Request within WOS.
- ZWC Identifies uniquely all cellular accounts for wireless carriers with a 4 digit code. Work groups are established by Customer ZWC.






The Wireless Ordering System, or WOS, is new for BellSouth wholesale customers.

- Prior to WOS, there was no web or electronic interface entry order system for BellSouth wholesale, wireless customers.
- All orders were mailed, faxed or emailed to the Wireless Sales Account Team and/or the Wireless Service Center (WSC). This created a long paper trail and resulted in operational inefficiencies.
- To combat that, the Wireless Ordering System was created.
- WOS is a web-based ordering system which enhances and streamlines BellSouth's wholesale ordering process.
- The next section will address logging in to WOS.





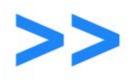





In order to access the WOS, users must have a username and password.


- The username and password will be maintained by Electronic Communications (EC) Support Group.
- Requests for access to the system will be monitored by the submission of a request form from the account team to EC Support.
- Upon a successful log in, WOS will retrieve and store a list of ZWCs the user is allowed to access.
- After log in, WOS will also retrieve and store permissions for functionality the user is allowed to access.




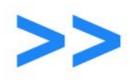
WOS Login Screen





View Sales Main Screen



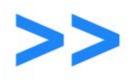

- A customer wants to change the specifications of existing trunks to alter their functionality.



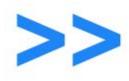

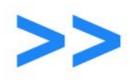


User Administration Functions




