Subject: CLECs – **REVISED**: Update of the BellSouth Business Rules for Local Ordering, Issue 9P (Originally posted July 3, 2001)

This is to advise that the BellSouth Business Rules for Local Ordering (BBR-LO), Issue 9P, will be posted to the BellSouth Interconnection Services' Web site on **Tuesday, August 28, 2001**. This BBR-LO update will affect documentation, electronic and manual order processing and may impact CLECs' operations.

Changes scheduled for Issue 9P:

- Remove FBI field on R/C/O table(s) for ACT=D.
- Modify Business Rule for FBI field.
- Add Note under 'Hunting Group Activities' header for REQ TYP E-Hunting section.
- Add Note under 'Completing the Hunting Section on the LSR Form/Screen ' header for REQ TYP M-Hunting section.
- Update the LNA table on UNE BRI/ISDN to show DISC NBR as Required on REQ TYP A ACT V.
- Change in documentation under [BellSouth® Centrex® Ordering Document Line-By-Line Instructions] to change narrative in parenthesis of line 22 describing types of LNA= C.
- Add Business Rule to ATN field on LSR Form Administrative section.
- Add Business Rules for LNEXT field in the Port Service (PS) Service Details Sections fields for (ISDN BRI UNE).
- Updated General Information section to reflect manual ordering procedures for LSR's greater than 100 pages.
- Add the description of Line Class of Service in the Data Element Dictionary, to the Port Service section.
- Update BBR-LO R/C/O Table(s) for DTKACT REQTYPE N (DID) to add (m) for manual next to each field, and to remove electronic table and any reference to electronics from the Data Element Dictionary for DTKACT and DTK.
- Update the Data Element Dictionary to add the description of Line Level class of Service [LNECLS SVC field] for the Port Page.
- Update the Data Element Dictionary, Resale Service and Port Service, (FEATURE Field) to add a business rule.
- Update the Data Element Dictionary section, Port Service, (FEATURE DETAIL field) to change the example for a feature detail from a telephone number to a valid Field Identifier (FID).
- Update the BBR to remove DS1 information for REQ TYP A Loops section and add DS1 information to the DS1, DS3, and STS-1 section of the BBR.

- Added 'LSO' to Required column of REQ TYP A / ACT D (xDSL) R/C/O table.
  - Added 'LSO' to Required column of REQ TYP A / ACT D (UCL-Unbundled Copper Loop) R/C/O table.
  - Updated Ordering Forms table (Complex Products REQ TYP E IDSN-BRI) for DL column to change 'O' to "C" and DSCR column change a 'C' to "O").
  - Added LNA of 'G' "Conversion or Migration to new LSP as specified (specify all features requested for Conversion Service)" to LNA table for Valid Entries.
  - Added Note [Wiring Non-Basic] under REQ TYPE/ACT TYPE (ACCOUNT LEVEL) table "For all other ACT TYPs, refer to the Product Specific Ordering Document"
  - Add Project management definition/description in the General Local Service Order Information section.
  - Added "See Service Request Changes and Cancellations for FOCs on cancelled LSRs" under Firm Order Confirmation (FOC) header.
  - Added additional paragraph covering "no manual FOC for manual SUP1 (cancel)" under Service Request Changes and Cancellations header.
  - Added additional flow-through (LNP to Resale) parameter under Flow-Through Parameters header.
