Subject: BellSouth Interconnection Services' Customers - Automatic Number Identification (ANI) Conversion Schedule of the Alabama 334/251 Area Code Split

With the introduction of the new 251 area code in the Mobile, Alabama Local Access and Transport Area (LATA), **as previously announced in the January 25, 2001 Network Notification Letter SN91082188**, BellSouth will continue the process with planned ANI conversions for all switch types in the area. The ANI conversions will begin on September 8, 2001, and conclude on November 14, 2001. A detailed ANI conversion schedule is attached for your information and use.

All work will begin at approximately 7:00 PM Central Time and will be completed by approximately 12:00 Midnight Central Time. Please refer to the attached schedule for specific dates.

Integrated Services Digital Network (ISDN) customers will be required to change the Service Profile Identifier (SPID) numbers in their ISDN equipment during the ANI conversions. All ISDN customers will be notified by mail to make the necessary changes to their equipment.
