Subject: CLECs – **REVISED** - Updates to the BellSouth Products and Services Interval Guide – Issue 4F (Originally posted on October 29, 2001)

This is to advise that several additions and updates will be made to the BellSouth Products and Services Interval Guide. These updates, designed to enhance the CLEC ordering process, will appear in Issue 4F of the Interval Guide scheduled to be posted to the BellSouth Interconnection Services' Web site by Friday, November 30, 2001. The following updates will be effective with the posting of the Interval Guide and may impact the CLEC's operation:

- Add Disclaimer Statement to Interval Guide
- Modify Integrated Services Digital Network/Primary Rate Interface (ISDN/PRI) intervals in Complex Resale Interval Table (REQTYPs E, N, P) (ACT N, T, C, P, Q, V) and Complex Switched Combination Interval Table (REQTYP M) (ACT N, V, C)
- Add new product, Remote Site (RS) HFS Unbundled Line Share Data Local Exchange Carrier (DLEC) Owned Splitter in the Unbundled Network Elements (UNE) Interval Table
- Add new product, BellSouth 256 Digital Subscriber Line (DSL) Service (Kentucky only) (ACT N, T, C, V) to Complex Resale Interval Table (REQTYPs E, N, P), (ACT N, T, C, P, Q, V). Add BellSouth 256 DSL Service (Kentucky only) to Complex Resale Interval Table (REQTYPs E, N, P) (ACT W)

**In order to clarify a point of misunderstanding in the Interval Guide, BellSouth is also updating the Guide by removing particular references to Local Service Requests (LSR) received before and after 10:00 am and 3:00 pm. These updates are being treated as if they were Type 6 Change Requests and, thus, are effective immediately with the posting of this Carrier Notification Letter. The Interval Guide will reflect these updates with the posting of Issue 4F by Friday, November 30, 2001. The updates are:**

- **Introduction – Remove references to LSRs received in Local Carrier Service Center (LCSC) before and after 10:00 a.m.**
- **Non-Complex (Residence, Business Coin) Resale – Modify Targeted LSR Processing Intervals as follows: Electronic Flow-Through LSRs – 3 business hours; Partially Mechanized LSRs – 10 business hours; Manual**

**LSRs – 36 business clock hours. Remove before and after 10:00 a.m. references.**

- **Non-Complex (Residence, Business Coin) Switched Combinations – Modify Targeted LSR Processing Intervals as follows: Electronic Flow-Through LSRs – 3 business hours; Partially Mechanized LSRs – 10 business hours; Manual LSRs – 36 business clock hours. Remove before and after 3:00 p.m. references.**
- **Unbundled Network Elements – Modify Targeted LSR Processing Intervals as follows: Electronic Flow-Through LSRs – 3 business hours; Partially Mechanized LSRs – 10 business hours; Manual LSRs – 36 business clock hours. Remove before and after 10:00 a.m. references.**
- **Number Portability – Modify Targeted LSR Processing Intervals as follows: Electronic Flow-Through LSRs – 3 business hours; Partially Mechanized LSRs – 10 business hours; Manual LSRs – 36 business clock hours. Remove before and after 10:00 a.m. references.**
- **Operator Services and Directory Assistance - Modify Targeted LSR Processing Intervals as follows: Electronic Flow-Through LSRs – 3 business hours; Partially Mechanized LSRs – 10 business hours; Manual LSRs – 36 business clock hours. Remove before and after 10:00 a.m. references.**
