Subject: PSPs - Tennessee Refund Interest Over-Calculation on Usage

In December 2000, the Tennessee Regulatory Authority (TRA) ordered BellSouth to reduce its rates for Smartline and Pay Telephone Access Service (PTAS) lines in Tennessee and to pay refunds as a result of this reduction. BellSouth issued these refunds in February 2001, and BellSouth also issued additional refunds to certain PSPs in September 2001 in order to address certain items including usage charges.

To the extent that any of these September 2001 refunds addressed usage charges, these refunds were overstated due to an inadvertent programming error that incorrectly calculated the amount of interest due on such refunds. To illustrate the miscalculation, assume that the refund period was five months and that a given PSP was entitled to usage refunds of \$15 for Month 1, \$5 for Month 2, \$0 for Month 3, \$20 for Month 4, and \$10 for Month 5. In the attached document, Table 1 demonstrates the manner in which the interest due on these usage refunds should have been calculated. Table 2 demonstrates the erroneous manner in which the interest paid on these usage refunds was actually calculated.

The PSP, in the illustration above, would have received \$1.75 of interest on the usage refunds instead of the \$0.73 of interest to which it was entitled. As a result, BellSouth will apply a debit in the amount of the difference between the interest actually paid for usage refunds and the interest that should have been paid on usage refunds. This debit will appear on the December bill of PSPs that were over refunded. For instance, the PSP in the example above would see a debit of \$1.02 (\$1.75 paid minus \$0.73 due) on its December bill.
