Subject: CLEC – **REVISED**: Electronic Interface Systems Downtime- ENCORE Release 10.3.2 (originally posted on January 9, 2002, and revised on January 24, 2002)

This is to advise of upcoming enhancements to the BellSouth Electronic Interface Systems. During these enhancements, the Electronic Data Interchange (EDI), Local Exchange Navigation System (LENS) and Telecommunications Access Gateway (TAG) systems will be unavailable for Local Service Request (LSR) processing on Saturday, February 9, 2002, from **7:00 PM** EST until Sunday, February 10, 2002, 12:00 NOON EST.

This release will support the Florida NPA split for the 561/772 area codes.

The due date enhancements for non-complex Resale and Unbundled Network Elements-Platform (UNE-P) (REQTYPE E&M) were implemented on February 2, 2002 in Encore Release 10.3.1. The enhancements included providing "Quick Service" type intervals on Local Service Requests (LSRs) received by 3:00 PM.

The Change Control Defect CR0520 (Reqtype M, Activity of V, LNA of V) was included in Release 10.3.1. During testing, additional issues were uncovered that could not be corrected in Release 10.3.1. Currently, CR0520 provides extended due dates when features are deleted and added on conversion UNE-P LSRs.

Also during testing of Release 10.3.1, it was discovered that when the line Uniform Service Order Code (USOC) is populated in the feature field, a due date will not be calculated and continues to provide the message "Cannot Calculate Due Date. Due Date will be provided on the Firm Order Confirmation (FOC)." These defects will be corrected in Release 10.3.2.
