Subject: CLECS --**REVISED** - Emergency Maintenance, ENCORE Release 10.4.1  
(Originally posted March 27, 2002)

This is to advise that BellSouth implemented a correction for defect CR0706 – “Svc. Order generator defect for Call Forwarding/Busy and Don't Answer Numbers.” This defect was corrected during the normal nightly maintenance window for Local Exchange Service Order Generator (LESOG).

Additionally, on March 26, 2002, two production defects were reported and validated against functionality implemented in Release 10.4. The defects were not detected during pre-release testing executed by BellSouth and CLECs in CLEC Application Verification Environment (CAVE). Both defects were corrected with this release on March 28, 2002.

The first defect, CR0715, was incorrectly auto-clarifying a Local Service Request (LSR) when the LSR Hunt Activity (HA) field is populated with “E” (existing). The software was modified to allow migration of existing hunting with or without population of the HA field.

The second defect, CR0716, was causing a LSR to auto-clarify when certain BellSouth Calling Card Uniform Service Order Codes (USOC) (BSX, BSX++) are on the account. The software was modified to remove the USOC, using an “O” action code instead of auto-clarifying.

**Also, a third production defect, CR0713, was reported and validated against functionality implemented in Release 10.4. The defect was causing sporadic error messages for the Local Exchange Navigation System (LENS) on Loop Makeup Service Inquiries (LMUSI). This defect was corrected with the implementation of Release 10.4.1 on March 28, 2002.**
