Required/Conditional, Optional (R/C/O)**

GENERAL LOCAL SERVICE ORDERING INFORMATION

UNE-P (Switched Combination) to Resale

Description

This section will provide information on ordering when converting/migrating Unbundled Network Elements-Platform (UNE-P) (Switched Combination) to Resale. This Process allows a CLEC End-User to migrate/convert a telephone number(s) from a UNE-P (Switched Combination) to Resale.

Restrictions

- Manual Ordering Only for ACT of Q
- Electronic Ordering for ACT of P, V or W

Ordering Guidelines

- REQTYP: E
- ACTTYP: V, P, Q or W
- LNA: V, G, X, D, W, P or N
- R/C/O and LNA Tables: Follow and use the appropriate Resale REQ TYP E Guidelines
- Due Date: Follow BellSouth Products and Services Interval Guide

Ordering Forms/Screens

The following chart illustrates the required, conditional and optional forms for ordering this service.

*** = DSCR is required to indicate:

- Captions
- Degree Of Indent
- Irregular Placement

**** = RS form/screen is required only when the ACT is N, C, T, V, S, P or Q. Otherwise, the RS form/screen is not required.

Completing the Local Service Request Form(s)

When converting/migrating UNE-P (Switched Combination) to Resale, the R/C/O Charts must be used. If also ordering line feature(s)/services, the **RESALE Form** is also required. Not populating these fields and/or forms will result in a clarification of the LSR. Follow the **REQ TYP E** specific ordering guidelines for the Required, Conditional and Optional (R/C/O) fields on the appropriate form(s).
