When a new account is established, a login user name and password will be issued and forwarded to the CLEC contact. (To access the form online, go to the login box and click on the words "Request a Password," which is under the user name and password input fields. See attached screen print.)

In order to view your company's SQM/PMAP/SEEM measurement data accurately, all applicable Operating Company Numbers (OCN) and Access Customer Name Abbreviations (ACNA) must be "mapped" to your company. Any data related to OCNs/ACNAs not "mapped" to your company will not be available for your company to view. Please complete the form with all the correct OCNs and ACNAs utilized in the BellSouth region for your company in order to facilitate accurate data on the BellSouth PMAP Web site.

If your company already has login capability, please verify that all of your company's OCNs and ACNAs currently used within the BellSouth area are "mapped" correctly. All "mapped" OCNs and ACNAs are listed on the Switchboard page of the BellSouth PMAP Web site for review. If additions or changes are required, please complete the form located on the PMAP Web site used to establish a new account and forward to your company's BellSouth Account Executive. The new form should include all OCNs and ACNAs for your company to replace the information previously provided.

Due to mergers, acquisitions and the daily changes, each company must be responsible for providing BellSouth with updated OCN/ACNA information related to its company.

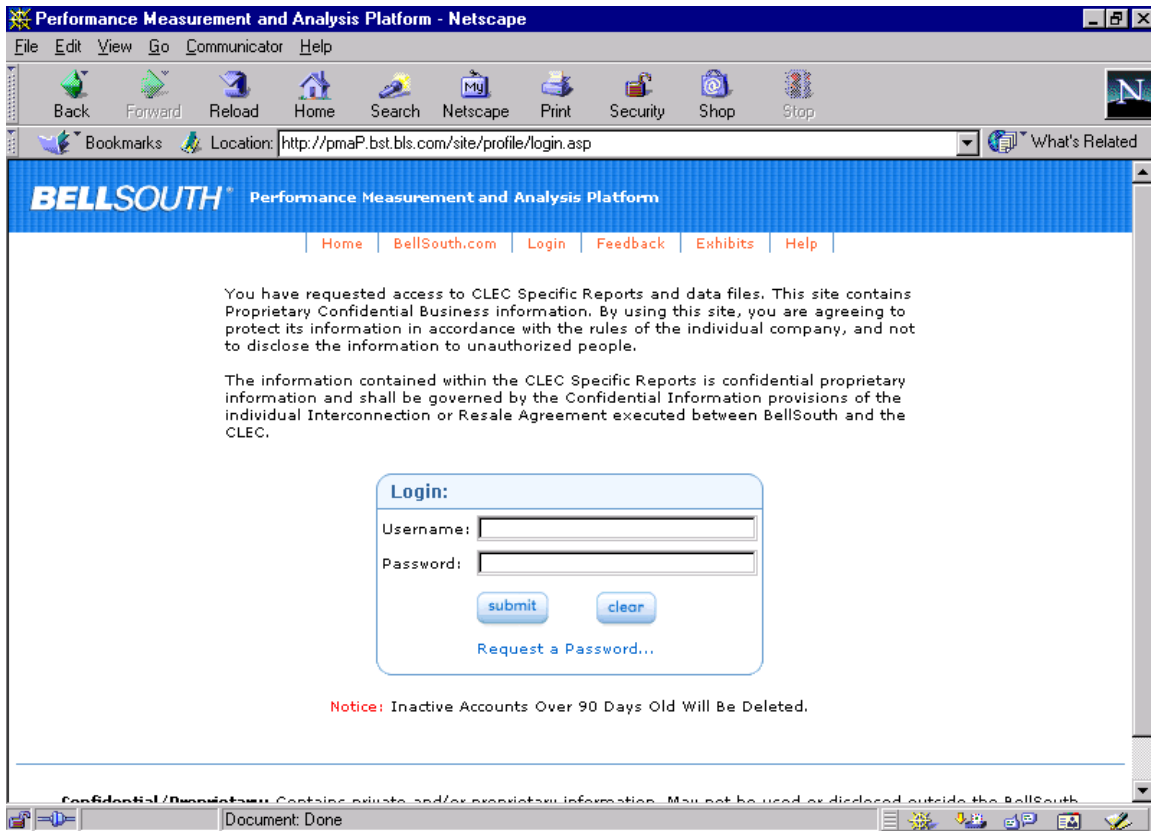
