<b>The present Interval for Line Share is 3 Business Days for 1 – 4 TNs</b>			
<b>The present Interval for Line Share is 5 Business Days for 5 – 9 TNs</b>			
1. A minimum of two orders will be issued for each LSR for Unbundled CO-Based Line Share to establish/change Line Share. Line Share Due Dates (DD) are calculated as follows:			
<u>QUANTITY PER LSR</u>	<u>TARGETED SVC INTERVAL</u>	<u>FOC INTERVAL</u>	<u>IN SERVICE INTERVAL</u>
1 - 4 TNs	2 DAYS	1 DAY	4 DAYS
5 - 9 TNs	2 DAYS	1 DAY	6 DAY
10 + TNs	Negotiated (LSR will Drop to LCSC for manual handling.)		
2. The system will calculate 2 business days with the cutoff time being 23:59 PM EDT for REQ TYP A, Line Share only.			
3. When a LSR is submitted with a SUPP 02 or 03, use current functionality for DD calculation.
