BellSouth Business Rules for Local Ordering Required/Conditional, Optional (R/C/O)

General Local Service Ordering Information

Local Number Portability (LNP) to Resale/Unbundled Network Element-Platform (UNE-P) Switched Combination Migrations

Description

LNP to Resale/ UNE-P Switched Combination Migrations allows a CLEC End-User to migrate (Port In, Port Back, Port Back Non-Home) a telephone number from a Facility-Based Provider to a Resale/UNE-P Switch Combination Local Service Provider (CLEC).

Restrictions

- Manual Ordering Process Only
- LNP Telephone Numbers that have been disconnected do not qualify for this process.

Ordering Guidelines

- REQTYP: E, M, N, P
- ACTTYP: V, P, Q
- LNA: V, G
- R/C/O and Line Number Activity (LNA) Tables: Follow and use the appropriate Resale/UNE-P Product Guidelines.
- Firm Order Confirmation (FOC) will be received from the BellSouth Local Carrier Service Center (LCSC) or Complex Resale Support Group (CRSG), depending on Service being ordered.
- FOC and concurrence from the Facility-Based Provider to the LCSC has a **48-hour** turn-around time.
- Remark Information: State that numbers are being Ported Back/In and list all telephone number(s).
