The following change must be made to the VER entry in the Data Dictionary for the EU, LSR, LS, LSNP, NP, PS, RS, DL, DSCR, PSA, DRS, and LSR Hunting pages.

#### **VER - Version Identification (DL)**

##### **Business Rules**

Rule 1: The CLEC must populate this field to indicate the PON is a SUP and not the original.

Rule 2: The CLEC must populate this field with an incremental number at least one digit higher than that of the preceding supplement to this PON.

Rule 3: On an initial LSR, the VER field must be 00 or blank.

Rule 4: This entry must be identical to the VER on the LSR form/screen and all other forms/screens submitted on this request
