Traffic Reports refer to the function that provides periodic reports of usage, peg count, overflow measurements for Network Access Registers (NARs), Trunk Groups, MultiLine Hunt Groups, Subscriber Line Measurements, Customer Facilities Groups (CFG), Attendant Consoles, UCDS, SFGs and UNE P Services.

These reports vary based on CO types and equipment availability.

This service essentially completed traffic studies, which indicate to the customer how well the leased facilities are performing.

Anyone who leases or utilizes facilities interfacing with BellSouth switching machines is eligible to receive Traffic Reports (TR).

Charges are applicable for all Traffic Reports (TR) requested by and provided to the customer (except for Florida, and North Carolina - one TR per system, annually at no charge is available). TRs are done on a per measurement ID (i.e., Trunk Group, SFGs, Single Line Usage).

The completed form and all requests for Traffic Studies should be submitted to the Account Team/CRSG.

Once the Traffic Study Request is received:

1. The CLEC is advised by phone that the request has been received.
2. Time frame for processing of the study is 3 -4 weeks.
3. Results are provided via email or regular US mail at the CLEC's choice.

Traffic Study form must be faxed to the CRSG.

- 4b. Day of the Week -. Identifies the first day of the requested study period (e.g. Sunday).
- 4c. Study End Date -. Identifies the end date of the requested study period.

9. Does this request need to be coordinated? Indicate Yes or No. If 'Yes', provide details if this study needs to be coordinated with other studies.

This field consists of up to a twelve character code where the:

First two numeric characters (position 1 and 2) are required and represent the physical conductors, which describe the number of wires that traverse the secondary ACTL or end user location.

Next two alpha characters (position 3 and 4) are required and identify signaling and/or transmission characteristics.

Next alpha/numeric character (position 5) is required and describes the impedance with which the customer / end user will terminate the channel for the purpose of evaluating transmission performance or to indicate if the circuit is fiber.

Next character (position 6) is a period (used as a delimiter) only if additional characters will follow.

Next three alpha / numeric (position 7, 8, and 9) describe the protocol options.

Next character (position 10) is a period (used as a delimiter) only if additional characters will follow.

Next alpha character (position 11) describes the transmission level to be received at the customer /end user interface from the provider.

Next alpha character (position 12) describes the transmission level to be transmitted from the customer / end user interface to the provider.
