Subject: CLECs – (Billing) **REVISED** - Update to the Geographically Deaveraged Unbundled Network Elements (UNE) Rate Zones (Originally posted on August 26, 2003)

This is to advise that effective **November 1, 2003**, BellSouth will make modifications to the geographically deaveraged UNE rate zones. **On September 22, 2003, the Georgia Public Service Commission issued its Second Order on Reconsideration in the UNE Cost Proceeding (GPSC Docket No. 14361-U, Phase I) which added three (3) wire centers to the list of wire centers affected in this proceeding. The three (3) additional wire centers are: GNSVLGAMA, SNLVGAMA and STBERGANH.** Please be advised that billing for the rate zones will be affected.

Attached for your review, is a list of all affected **wire center** Common Language Location Identifications (CLLI) and zone values.
