Telecommunications Access Gateway (TAG) Extensible Markup Language (XML) will also become available for testing at that time.

The CAVE environment will be **unavailable** for any CLEC testing from January 26, 2004, through January 30, 2004. This extended CAVE downtime is required to prepare the CAVE environment for the upcoming release.
