Subject: All Interconnection Services Customers – (Product/Service) – **REVISED** - BellSouth® FlexServ® Service (a.k.a. BellSouth SPA Customer Reconfiguration) Surveillance Feature/ SMARTRing® Service Promotional Plan (Originally posted July 15, 2004)

This is to advise that on July 31, 2004, BellSouth's tariff promotional offering for FlexServ® service Surveillance Feature for Dedicated Ring OC3, OC12, OC48 and OC192 will become effective. The promotional period is from August 1, 2004 through **October 31, 2004**.

This promotion provides a credit, when the customer orders the Surveillance feature in conjunction with a new SMARTRing® service (a.k.a. BellSouth SPA Dedicated Ring) during the promotional period. The Surveillance feature for SMARTRing service is a FlexServ service option in Section 7 of the BellSouth Tariff FCC No. 1. The Surveillance feature (a.k.a. BellSouth SPA Customer Reconfiguration) is provided Per Node with options for OC-1, OC-3, OC-3+, OC-12, OC-48, OC-48+, and OC-192+ SMARTRing service.

Customers will receive a three-month credit of the Monthly Recurring Charges (MRC) per node associated with the Surveillance feature. Customers must utilize the Surveillance feature for a minimum of three months, after which time they will have the option of continuing to use the feature at the appropriate monthly recurring charges or disconnect the feature. Customers electing to disconnect the feature must notify BellSouth within thirty (30) days following the three-month minimum period. Any applicable termination liability associated with a Channel Services Payment Plan (CSPP) will not apply. However, if a customer disconnects the feature any time after 30 days following the three-month minimum period, any applicable CSPP termination liability will apply. Ordering and implementation may begin on the effective date of the tariff. Carrier Access Billing System (CABS) bills will be rendered in the same manner that existing bills are rendered to the designated Billing Account Number (BAN).

To take advantage of these offerings, customers can order FlexServ service Surveillance feature in conjunction with a new Dedicated Ring service from Sections 7 or 23 of the BellSouth Tariff FCC No. 1 via the normal Access Service Request (ASR) process following negotiations with the customer's BellSouth account team representative.
